- iii. To prepare requirements in respect of teaching the subject at various courses including teachers' qualifications and infrastructure, such as a library, laboratory, equipment, consumables, etc. for consideration of Academic Council and Executive council through School Council
- iv. To make recommendations to the Academic Council through School Council regarding the norms of recognition of postgraduate teachers.
- v. To make recommendations to the Academic Council through School Council regarding the conduct of university courses.
- vi. To recommend names of suitable persons for inclusion in the panels for appointment of paper-setters, examiners, and moderators at the University examinations in the subject.
- vii. To suggest the organization of orientation and refresher courses in the subject.
